

# Seminar: "Doing business with North-Korea" (Beijing, 21 September 2009)

In the current financial and economic situation, companies face many challenges. They must cut costs, develop new products and find new markets. In these fields, the Democratic People's Republic of Korea (DPRK, also known as North-Korea) is an interesting option.

North-Korea is opening its doors to foreign enterprises. It established several free trade zones to attract foreign investors and there are several sectors, including textile industry, shipbuilding, agro business, logistics, renewable energy, mining and Information Technology, that can be considered for trade and investment.

North-Korea is competing with other Asian countries by offering skilled labor for low monthly wages and by offering tax incentives. Last year, North-Korea's exports rose with 23 percent and its imports with 32 percent. Although China is a main partner, trade with Singapore grew with 116 percent. The



last Pyongyang Spring International Trade Fair in May saw participants from more than 17 countries. Foreign investors are now involved in large projects, such as in mobile communications and the completion of the Ryugyong Hotel (see photo), which is to become one of the largest hotels in Asia.
